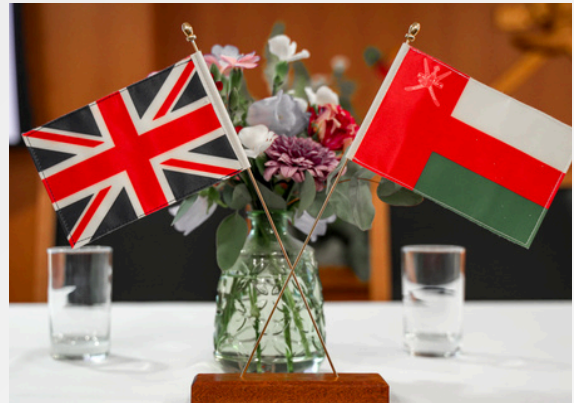


About the NGG

The Speakers



Sir Alan Duncan KCMG

Former Foreign Minister and SOAS Board Member

Sir Alan spoke on the topic of **'Strategic Diplomacy: UK–Oman Relations in a Changing World,'** highlighting Oman's unique role as a trusted mediator, its moral courage, and its capacity to drive positive change, drawing attention to aspects of Omani diplomacy from which the UK can take valuable inspiration.



Mikey Clark

CEO of Relode

Mikey Clark spoke on **'Harnessing Renewable Energy: British Omani Partnership,'** underscoring the criticality of energy and reflecting on key learnings from the past decade regarding the urgency of renewable solutions. He highlighted the rapid emergence of renewables in Oman, while also noting lessons from Oman's hydrocarbon history and the UK's own energy transition. His forward-looking dialogue showcased opportunities for both nations in shaping a sustainable energy future.



Professor Tim Evans

Professor of Business and Political Economy, Middlesex University London

Professor Tim Evans spoke on **'Reflections on Omani, British and International Trade for the 21st Century,'** highlighting the human instinct to trade and Oman's remarkable progress on the global stage. He noted the strong UK–Oman bilateral trade relationship, valued at USD 2 billion with a balanced split, and the UK's position as Oman's largest investor, with FDI rising from USD 23bn to 35bn. Tim emphasized the role of trust, youth engagement, and tourism in deepening ties, and reflected on shifting global power dynamics and Oman's strategic position at the centre of emerging trade routes.

Jose Amorim

Managing Director of NJP Oman

Jose Amorim spoke on '**Future Sustainable Developments: Modern Methods of Construction**,' introducing NJP Oman and its commitment to sustainable construction. He emphasized circular design, low-carbon materials, and adaptable buildings to meet Vision 2040 goals, outlining NJP's model for reducing emissions and delivering modular, energy-efficient infrastructure. Jose highlighted how Modern Methods of Construction (MMC) enable faster delivery, higher quality, and reduced waste, offering advantages for Oman's remote developments, industrial projects, and tourism expansions.



Andrew Roughan

CEO of Plexal

Andrew Roughan spoke on '**Innovation and Technology: Bridging the UK-Oman Tech Ecosystem**,' introducing Plexal and its role as an innovation hub driving collaboration between startups, corporates, and governments. He emphasized the importance of building strong international partnerships, fostering entrepreneurship, and enabling technology transfer to accelerate growth across both the UK and Oman.



Andrew Williamson

Managing Director, Cambridge Innovation Capital

Andrew Williamson spoke on '**The Sovereign Investment Partnership: Enabling Joint Investment**,' introducing Cambridge Innovation Capital and its long-term partnership with the Oman Investment Authority. He highlighted the value of knowledge transfer in supporting IP commercialization in Oman, showing how both nations benefit from shared expertise and long-term value creation.

Dr. Andreas Krieg

Senior Lecturer School of Security Studies, King's College London

Dr Andreas Krieg spoke on '**Network-Centric Statecraft and the Gulf**,' outlining how modern statecraft is increasingly shaped by networks across governments, business, and civil society. He highlighted how influence emerges from connectivity, where hubs of capital, ideas, security, and people gain strength through their links. Dr Krieg explored how Gulf states, including Oman, are using these ecosystems to build resilience and adapt to shifting geopolitical realities, reinforcing the importance of collaboration within the UK–Oman relationship.

Visits

Visit to bp London Offices

A highlight of the NGG delegation was the visit to bp, meeting with **Tural K. Valiyev**, Vice President Social Performance, and **Leo Morris**, Sustainability Analyst, bp. The delegates received a briefing on the company's sustainable practices. The discussions emphasized the importance of responsible approaches to energy and a clear focus on supporting local communities.

Visit to the Foreign, Commonwealth and Development Office (FCDO)

The NGG delegation met with **Tom Allen**, Deputy Director and Head of the Gulf Department, who provided a regional update that underscored the importance of UK–Oman cooperation in navigating complex regional dynamics. Delegates also toured the historic FCDO building, gaining insight into its heritage and role in shaping British diplomacy.

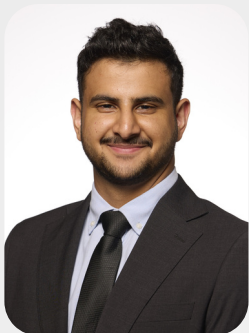

Future UK-Oman leaders gather for BOS Programme

LONDON: The British Omani Society (BOS) will host its 12th Annual New Generation Delegation (NGG) in London from November 26-27, welcoming 24 early-career British and Omani professionals committed to advancing the longstanding UK-Oman partnership. The 2025 programme is sponsored by bp.

The flagship initiative creates a vibrant platform for rising leaders to engage in the evolving dimensions of bilateral cooperation – including diplomatic, trade, renewable energy, technology, innovation, sustainability, and regional strategic affairs. Hosted at BOS headquarters in Mayfair, the two-day programme will feature lectures, panel discussions, and networking sessions led by prominent figures from the government, academia, and industry.

Confirmed speakers include Rt Hon Sir Alan Duncan KCMP, former UK Foreign Minister, Prof Tim Evans, Middlesex University, Andrew Williamson, Cambridge Innovation Capital, Andrew Roughan, CEO, Floral, Henning Glynnis, Eurasia Group and senior experts from bp.

The key focus areas are the Future of UK-Oman strategic diplomacy, renewable energy and energy transition partnerships, Omani, British and global trade dynamics, technology and innovation collaboration, regional geopolitical shifts in the Gulf and sustainability and the green transition.

Delegates will also visit bp's London headquarters and the UK Foreign, Commonwealth and Development Office (FCDO), gaining insights into international energy strategy and government-level cooperation. The programme will conclude with a networking reception attended by business leaders, senior officials, and participants from Oman's Royal Academy of Management Startup Leadership Programme.

Shaikh Maan bin Hamad al Rawahi, Trustee of the British Omani Society and Co-Chair of the New Generation Group, said: "Preparing the next generation of Omani and British leaders is essential to sustaining the strength of our nations' partnership. 'The NGG provides a platform for future leaders to exchange ideas, develop skills, and build meaningful connections that will shape UK-Oman relations for years to come.'"
